## Re: Moving On from Meadow High School (Phase Transfer 2023-2024)

Some of our young people may decide to leave Meadow High School in Year 12 or 13 and choose to continue their education elsewhere.

Attached to this letter is a form that needs to be returned to the SEND department at Hillingdon Council. If your young person is in Year 12/13 and you want them to remain at Meadow High School for the next academic year, ***you still need to return the form to show that this is what you and/or your young person wants.***

If your young adult is in year 14 and thinking about what setting recent learners have moved onto, some of the destinations include;

- Orchard Hill College, Uxbridge
- Green Corridor, Hillingdon
- Uxbridge College, Uxbridge
- BCA (Berkshire College of Agriculture), Maidenhead
- Great Oaks, Hounslow

The Local Authority has to name a placement for your young person by 31st March 2024, this is why the SEND department at Hillingdon needs to find out what your young person wants to do. Do they want to stay at Meadow High School, or do they want to continue their education elsewhere?

The Local Authority needs to know:

- Do you want to go to college (or training) in September 2024?
- Do you want to join a training provider in September 2024?
- Or do you want to leave school and try to get a job?
- Or do you want to stay at Meadow High School?
- If you are planning to go into college (or training) in September 2024, which one would you like to go to?

Please see the form for you to complete and send back to the SEND department at Hillingdon Council.

- If you are not sure which one just yet, please return the form to SEND.
- If you don't have a particular college or training place you would prefer, please return the form to SEND,
- **If you or your young person wants to stay at Meadow High School, please return the form.**

Please be aware that pupils with EHCP are not automatically entitled to transport to an education setting. Some pupils will be eligible for home to school transport and more information on this can be found at:


